# A Review on the Development of Global Ethic Project: A Study on The Global Ethic Foundation

### ABSTRACT

Global ethic is an idea that claims an existence of one basic morality shared among people regardless of their race and religion since the beginning of humanity. It is founded on treatment among people that is humane and fair. From this foundation, the idea is elaborated into some attributes and criteria that form the moral framework that is collectively named as global ethic. To spread the idea, some activities are done under the Global Ethic Projects. This paper will review on the development of an organization that is directly related to Global Ethic Projects which is The Global Ethic Foundation. It will also examine activities and programs held, and also scrutinize the long-term planning of the organization in order to introduce global ethic to the world. The discourse will then be concluded with a summary on the current position of global ethic.

**Keywords:** Global ethic; The Global Ethic Foundation; Global Ethic Projects; Inter-cultural and Inter-religious.

#### Introduction

Global ethic is elaborated as one basic morality that is integrated in all religions and ideologies. The initial idea on global ethic is introduced by Hans Küng<sup>1</sup> who describes it as "a basic consensus on binding values, irrevocable criteria and personal basic attitudes".<sup>2</sup> According

to Küng, global ethic is not a new religion or a new global ideology or new set of teachings to replace ethical values that are readily exist, far less a uniform world religion beyond all existing religions; but he claimed that it is believed and practiced by people of different faiths and religions since the beginning of human civilization in the world. Two essential core of global ethic are humanity which is 'every human must be treated humanely' and the golden rule that is expressed as "treat others as you would like to be treated".<sup>3</sup>

The concept of global ethic has taken the center stage of the world community and was discussed in a United Nations meeting and was made a declaration in the meeting of Parliament of the World's Religion in Chicago in 1993.<sup>4</sup> To encourage global ethic projects, a foundation has been established to lead it. This article will review on the developments of global ethic projects and efforts done in advocating it globally. The article will specifically look at the development of an organization that is directly related to the global ethic project which is The Global Ethic Foundation. This article will also examine activities and programs held and scrutinize the long-term planning of the organization to introduce global ethic to the world. The discourse will be concluded with a summary on the current position of global ethic.

## **Founding History**

The Global Ethic Foundation has been established by Count Karl Konrad von der Groeben (1918-2005), a German entrepreneur in 1995. The foundation was established after he was inspired by Global Responsibility; a book written by Hans Küng published in the 1990.<sup>5</sup>He has contributed a large sum of money to disseminate the idea of global ethic using the newly founded organization.<sup>6</sup>He believes that these ideas should be inculcated in people to be practiced in their life. The Global Ethic Foundation is based in Tübingen, Germany and there are other branches in other countries such as Switzerland, Austria, Czech Republic, Hungary, Brazil,

Colombia, Mexico and China.<sup>7</sup> In terms of organization, the foundation is lead by Hans Küng as the President and Karl-Josef Kuschel as the Vice President. It employs a board of advisers with the role to ease transmission of ideas in discussing relevant activities of the foundation and funding on organizing activities to spread global ethic.<sup>8</sup>

# The Objectives of The Global Ethic Foundation

The Global Ethic Foundation has set three objectives of its founding. The objectives are also joined with strategies to achieve those objectives which are<sup>9</sup>:

a. To carry out and encourage inter-cultural and inter-religious research:

This aim will be achieved in particular through theological and other research into the foundations of the religions, especially through the production and promotion of academic publications (books and articles) in the interest of inter-cultural, inter-religious and inter-denominational understanding.

- b. To stimulate and implement inter-cultural and inter-religious education: This aim will be achieved in particular through:
  - i. Teaching and lecturing to disseminate the results of the research sponsored by the Foundation, especially the ideas relating to a fundamental ethic common to all men and women, a global ethic. This will be done in churches, colleges, academies, schools, universities, associations and interested groups of every kind, both national and international;
  - ii. Further education of those interested, through conferences, lectures, seminars or workshops aimed at deepening the themes of a global ethic;
  - iii. Publicity to promote a global ethic through the media (newspaper articles, interviews, radio and television programs).
- c. To enable and support such inter-cultural and inter-religious encounter necessary for research and education:

This aim will be achieved in particular through:

- i. The stimulation and encouragement of initiatives in society, politics and culture in the interest of understanding between peoples (e.g. confidence-building measures between the religions);
- ii. Promotion of encounters between people of different cultures and religions (colloquia, study trips and congresses); the development of the existing network of inter-cultural and inter-religious relations to further a global ethic;
- iii. Access to key documents and literature with the help of modern communication technologies.

Therefore, the three objectives outlined by the Global Ethic Foundation are to execute researches on global ethic, promote the results of the researches via various activities and

organize encounter between groups of different cultures and religions. All these objectives are functions to provide understanding on global ethic ideas and inculcate understanding among different communities via shared ethic medium. These three objectives are inline with the foundation tagline which is "For Inter-cultural and Inter-religious Research, Education and Encounter".<sup>10</sup>

#### **Programs and Activities**

Thus, the two main efforts that are implemented by the foundation is via organizing activities and research and publication projects. In terms of activities, there are a lot of projects previously organized by The Global Ethic Foundation. It can be divided into seven different domains which are religions, politics, economy, education, music and sports. This seven aspects function as a medium that is used by the foundation to spread its ideas. Therefore, some activities are organized based on the seven aspects.<sup>11</sup>

#### a. Religion

In terms of religion, there are at least three activities held by the foundation which are publication of various religious books authored by the foundation's own committee members, exhibition, multimedia projects, and also participation in religious programs. Publication of books on various religions, inter-religious dialogues and inter-cultural dialogues are among the first few efforts done by supporters of global ethic in promoting its ideas. In this context, the committee members are directly involved in writing efforts including Hans Küng as the President, Stephan Schlensog as the Secretary-General, Karl-Josef Kuschel as Academic Advisor and many others. Some books are translated to other languages to ensure that the idea can be spread to various targeted groups.

Hans Küng has previously written few books on religions and the importance of global ethic as a basis that connects the various religions. Among his important publications are three books on three main religions of the world which are *Judaism*<sup>12</sup>, *Christianity*<sup>13</sup> and *Islam*<sup>14</sup>. Karl-Josef Kuschel has also written some books on religions disciplines such as *Abraham*<sup>15</sup> and *Juden*, *Christen, Muslime*<sup>16</sup>. There are other writing on religions and its relations to global ethic as written by Schlensog and Bauschke on Hinduism<sup>17</sup>, comparative religion<sup>18</sup> and *Abrahamic Religion*<sup>19</sup>. In this context, Global Ethic Foundation did not publish the works, but serves to

spread them.<sup>20</sup> However, the books are mainly written in German and English. Limitation in language medium may limit the spread of global ethic ideas to communities which are not using these two languages. Other than that, these books are mainly circulated in certain places, specifically in Europe and are limited in other places.

Moreover, the Global Ethic Foundation also made an initiative by implementing a multimedia project that is displayed in global ethic exhibitions. This multimedia project is named as "Tracing the Way", which is a seven-series documentary titled "On the Trail of the World Religions". The documentary is on tracking world religions. Additionally a picture book on the documentary and CD-ROM was also published as additional materials.<sup>21</sup> The "World Religions – Universal Peace – Global Ethic" exhibition has been started since 2000 and presented in various languages in many places.<sup>22</sup> This is seen as one of the foundation efforts to introduce global ethic to the public and not only limited to academicians, politicians and religious leaders. Some of the foundation leaders are also actively participating in inter-religious and inter-cultural seminar and debates. Hans Küng himself is consistently active as a presenter in many inter-religious and inter-cultural seminars throughout the world.<sup>23</sup>

### b. Politics

Furthermore, the Global Ethic Foundation also uses political mediums to spread its ideas. Besides, politics has been a focus and main agenda in the context of global ethic. Therefore, on that basis, the foundation organizes many activities on political aspects. These activities can be divided into two aspects which is; (1) via United Nations as the main world body and; (2) political symposium and Global Ethic Lectures which is self-organized by the foundation.

The Global Ethic Foundation has played an important role in the United Nations via its President, Hans Küng by outlining resolutions for a declaration on "United Nations Year of Dialogue between the Civilizations" in United Nations meeting in 2001.<sup>24</sup> It was based on the

suggestions by Iranian President Khatami in 1998 who proposed inter-religious and inter-cultural dialogue and also to hold a Year of Dialogue on United Nations level. Furthermore, the world was recovering from the shock of the New York September 11<sup>th</sup> 2001 tragedy, and that further force the world body to raise the issue of civilizational and cultural clashes as an important topic to be understood by the world community.<sup>25</sup> Hans Küng has been given the responsibility to identify what is said as 'new paradigm principles in international relations' by the United Nations' Secretary-General Kofi Annan.

The results of the consensus have seen the principles to be devised via dialogues and understanding on shared moral values or briefly, global ethic.<sup>26</sup> The 56<sup>th</sup> United Nations meeting has discussed the above efforts and Hans Küng has been given the honor to read the statement as a result of the discussions. The report is then published under the title "Crossing the Divide. Dialogue among Civilizations". As a result of the report, United Nations General Assembly on the 9<sup>th</sup> November 2001 has ratified six-resolution article entitled "Global Agenda for the Dialogue among Civilizations".<sup>27</sup> The second article in the dialogue objective directly considers the role of global ethic in civilizational dialogue.<sup>28</sup>

In line with the achievements of the resolution, the foundation took an initiative to organize "World Religions - Universal Peace - Global Ethic" exhibition in the United Nations headquarters in New York.<sup>29</sup>This has been the greatest achievement by the foundation to spread global ethic on the international level. The United Nations resolutions in November 2001 and the "Crossing the Divide" report has been deemed as global ethic achievement on the highest level in international politics.<sup>30</sup>

Other than that, efforts to spread global ethic were done via symposium and series of lectures. For example, 'A new Paradigm for International Relations? Ethical Challenges for the Shaping of Global Politics symposium', held in 2002 and organized in Tübingen, Germany was directly related to political issues.<sup>31</sup>Additionally, the foundation also organized a series of lectures, or 'Global Ethic Lectures'. The invited speakers will give their own perspective on how global ethic is or can be applied in their own field. Among them are politicians such as Tony Blair, former Prime Minister of Britain and Helmut Schmidt, former German Chancellor, leaders of international organizations such as Kofi Annan, former Secretary-General of the United Nations and Mary Robinson, United Nations High Commissioner for Human Rights. The selection of international level speakers can be seen as one of the efforts by the foundation to promote global ethic globally.<sup>32</sup>They may represent certain organizations but nevertheless, it is enough to

project that the global ethic idea is greatly supported globally since they are dominant in the international level.

## c. Economy

The Global Ethic Foundation has also spread its effort based on the economic theme. Economy has been seen to be influential and affects majority of the world community. Economic scandals and crises in the 1990's and years afterwards has compelled the foundation to focus on the discussions on ethical framework of the global economy. Therefore economy is one of the important topics covered by global ethic. There are two efforts to spread global ethic in terms of economy. The first effort has been performed by Hans Küng himself by publishing a book entitled A Global Ethic for Global Politics and Economics. This book describes the need of global ethic based economy to the world and the need to leave economic system that is not fair and being monopolized by certain parties. Therefore, it is the first results that open global ethic to discussions in terms of its role to the world's economy.<sup>33</sup>

The second effort is the formation of an economic manifesto by the foundation. The "Global Economic Ethic - Consequences for Global Businesses" manifesto outlined some global economic ethics as an essential component in the field of economic activities.<sup>34</sup> It does not stop there, but it has been uplifted to the international level. In the year 2009, this manifesto has been presented in the United Nations headquarters with the cooperation of UN Global Compact, Swiss Permanent Mission to the United Nations and Novartis Foundation. It has been ratified by influential individuals from various fields and backgrounds.<sup>35</sup>This manifesto is then presented and discussed in many international level events such as in Peking University, China, in Novartis Foundation annual symposium in Basel, in Parliament of World's Religion in Melbourne in 2009, and in UN Global Compact Leaders' Summit in New York on 23<sup>rd</sup> to 25<sup>th</sup>June 2010.<sup>36</sup>The Global Ethic Foundation has also created a website for the promotion and spread of this manifesto.<sup>37</sup>

# d. Education

Global Ethic Foundation has also focused its efforts to spread its ideas via education especially in schools. This can be divided to two forms, which are; (1) unofficial educational means for instance, in the organizing of competitions in schools, and; (2) official educational

means for example by training teachers on global ethic. For the Global Ethic Foundation, explanation on the importance of global ethic should start as early as possible. This is because early education, especially in terms of relationships will influence one's attitude and character when they become adults. Family, pre-school education and schools are among important locations to children in learning ethical behavior. Therefore, the foundation focuses on schools by cooperating with the school's administration to spread global ethic through educational medium.<sup>38</sup>

Global Ethic Foundation also outlined two essential pillars in education framework which are communication of ethical competence and communication of intercultural competence. Based on these two educational objectives, the foundation encourages fundamental research and investigation on communication methods that is best suited for the targeted groups.<sup>39</sup>

Among the achievements by the foundation in terms of education is advocation to teachers to then actively participate in the works of the foundation as volunteers. These teachers are involved in seminars and global ethic teaching courses, gave lectures in schools and churches, organized projects for children and teenagers and helping the school in preparing ethical codes for the schools.<sup>40</sup> Furthermore, there are other school projects which are organized by the foundation such as inter-classroom competition that focuses on classroom developments in terms of inter-religion or communication of global ethic values. There are also global ethic themed creative learning projects competition that is held between schools (WASP - World Ethic School Prize).<sup>41</sup>

In the context of direct and official education, the foundation has prepared a collection of teaching materials on global ethic in German language which is *"Weltethos in der Schule"* (Global Ethic in the schools).<sup>42</sup> Also, teaching-training for teachers are also being developed, especially in the field of inter-religion. This training is based on materials as mentioned above.<sup>43</sup> With the training, the foundation hoped that global ethic can be spread in schools systematically and according to the perspective that they have outlined. There are two efforts that have been implemented in higher education levels. Firstly is the cooperation between the foundation and Pedagogical College of Central Switzerland in Switzerland to open an institute called as Global Ethic Competence Centre. This institute functions to develop global ethic themes for the use of the training for teachers and materials used in teaching.<sup>44</sup>

Other than that, Global Ethic Foundation in China with the cooperation of Sino-Christian Studies has translated global ethic teaching material to Chinese language for teachers in Hong

Kong. These teaching materials are also integrated into curriculum and student text books. In the year 2011, global ethic text book has been published for the usage in China.<sup>45</sup>

The foundation has also successfully established an institute called as Global Ethic Institute based on its president's ideas, Hans Küng. It was given birth from the cooperation of the foundation with the University of Tübingen, Germany. The institute was established after the decision in the senate meeting between the university and the foundation on May 2011 and it started working in the beginning of summer semester of 2012.<sup>46</sup> The institute can be said to be having a special structure as it is managed under two organizations, a foundation and a university. Therefore, it is not a free organization but it is having a close relation with the foundation.<sup>47</sup>

The institute is funded by *Karl Schlecht Gemein nützige Stiftung* (KSG), a non-profit based organization. Prof. Dr. Dierk Claus Meier act as the director of this institute and supported by Dr. Stephen Schlensog (Secretary-General, Global Ethics Foundation) as the manager. The objective of the institute is to encourage scientific and academic research and teaching on global ethic to the public. These include a wide range of disciplines such as world religions, international politics, global economy, education and culture. However, at the moment it is focusing on global economy.<sup>48</sup>

Programs that were organized ranges from classes and seminars. It also directly involved in devising learning programs for various courses. <sup>49</sup>Up until now, it is only opened to university students, but the institute hoped to organize programs that target the local communities.<sup>50</sup> Among the organized seminars are 'Professional ethics and attitude', 'Ethical decision-making - ethical dilemmas', 'Intercultural competence – Hinduism' and 'Business Ethics Case Studies'.<sup>51</sup>

If previously the Global Ethic Foundation is more focused on education in schools, with the establishment of this institute, efforts are more likely to be focused on higher education level through academic research and absorption of global ethic ideas in various university courses. This will directly bring global ethic issues that previously were spread to general public to the academics. A little study can be done on the institute as it is recently established. However, the institute is indeed having a greater role to ensure that global ethic ideas are relevant in the future through rigorous researches and educate the students who undergone the university courses.

# e. Sports and Music

The Global Ethic Foundation has also spread the ideas of global ethic by the means of musical and sports activities. These two aspects are prioritized because they are both closely related to the daily livings of the people. In music, the foundation has formed religions musical that was produced from religious text provided by Hans Küng. Global ethic themes were also integrated in the musicals and have been made as musical tunes.<sup>52</sup>It has been presented to the world in the fall of 2011 that involves a large children choir group and *Philharmoniker Berlin*, a symphony orchestra group.<sup>53</sup> For the Global Ethic Foundation, this project is the first effort to translate religions to musicals. It is targeted to the public using a medium that is close to them which is music. Another choir and orchestra performance has been held in June 2012 in Birmingham for the London Festival 2012 that was organized in accordance to the London Olympics. The choir lyrics combined excerpts from Judaism, Christianity, Islam, Hinduism, Buddhism and Confucianism religious texts was arranged by Hans Küng.<sup>54</sup>

In sports, the Global Ethic Foundation has led the global ethic concept through lectures on sports, for example a lecture by Hans Küng in the German Protestant Church Conference in Hannover on May 2005 entitled "Global Sports and Global Ethic". The global ethic and sports lecture is deemed as important because it was done in conjunction with the World Cup 2006 in Germany.<sup>55</sup>Besides, the foundation also invited Dr. Jacques Rogge, the President of International Committee to deliver the sixth Global Ethic Lecture in 2006 with the same title which is "Global Sports and Global Ethic".<sup>56</sup> In sports, the foundation is still focusing in academic aspects from the lecture series held. The foundations is yet to organize its own, or directly involved in any sporting events.

# f. Research and Publication

In addition to the efforts mentioned above, the Global Ethic Foundation also focuses greatly in spreading its ideas via research and publications. It greatly supports external scholars who are prepared to learn and spread any global ethic themed researches. Research grant is allocated to fund doctorate candidates, offer financial help or as a stipend for research projects, research visits and others.<sup>57</sup> Besides that, a number of symposiums and academic seminars were organized every year by the foundation<sup>58</sup>.

Moreover, global ethics are also spread via publications to communicate the ideas. It is authored by the foundation committee members and supporters of global ethic that are largely made of people from various academic backgrounds. Publications on global ethic explained the idea via various mediums such as religion, politics, economy, philosophy, science and education.<sup>59</sup>

#### Conclusion

In conclusion, there are three initiatives executed by the foundation which are research, education and encounter with target groups. Among these three undertakings, education is the core of the duties of the foundation.<sup>60</sup> The targeted group varies from country leaders and academicians to general public, university students and school pupils. There are various interreligious researches and activities; however, the planned and implemented projects are recognized as ethics projects and not religions projects. This is due to for Global Ethic Foundation what has to be focused on is the search of common points that can open doors to build inter-religious and inter-cultural understanding and not just focused on their differences.<sup>61</sup> Therefore, the foundation does not focused their efforts on doctrine and theological discussions, but rather on more 'practical' aspects, that serves to discuss and solve world's current issues. Thus, planned and implemented activities by the foundation must be related to the problems, issues and current realities (economy, culture, environment, politics and others) and it must be able to be practiced in human lives.<sup>62</sup>

Other than that, the foundation is seemed to be successful in spreading global ethic in some aspects, especially in politics and education. Global ethic has reached international level as it was discussed among influential international bodies. Still, this impact is seen as being partial as it only encompasses several locations. Global ethic may be successfully spread in the Europe, especially within countries with branches of The Global Ethic Foundation. There is no coverage of the idea in other countries, especially in Asia. This is because; most of the activities are concentrated in the same locations. The foundation was mostly active during the initial period following its establishment; however, its activities are starting to decline nowadays. But the new attempt in forming the Global Ethics Institute in one of higher institution in Germany is seen to be an effort that can hugely contribute and maintain its purpose of spreading ideas of global ethic especially in education.
